Secure platform

- All application access is over HTTPS
- DigiCert SHA2 Secure Server TLS_RSA_WITH AES 256_CBC_SHA (standard AES 256 Encryption)
- Application certificate uses the ECDHE (elliptical Curve Diffie-Hellman Encryption) cipher suite, which is the latest encryption strength (SHA256) and key strength (2048-bit).
- o Certificates/security measures are updated as called for by current and evolving standards.
- By appropriate agreement or stipulation, sessions can be recorded. This may be particularly valuable for mock hearings, mock trial and other related situations.
- Reduce the expense associated with smaller value hearings. Particularly useful for hearings run through the Alternative Fee Program.
- Increase participation in all hearings, regardless of the size
 - Experts
 - Carrier Representatives
 - Percipient witnesses
 - Parties
- Improve control over proceedings
 - Limit the instances where in-person contact is actually an initial or ongoing detriment to an effective hearing or mediation
 - Disruption, animosity and tension frequently slow, derail and create other challenges to effective mediation and arbitration hearings. Remote participation can allow a "presence and input" without the potentially distracting "drama." Those with an important interest need not be excluded.
 - With CourtCall's patent pending private sub-conferencing feature and private waiting rooms, you can replicate the common "caucus," "shuttle diplomacy" or "hallway conferences."
